The specific objectives of the assessment were to identify gaps, assess the quality and use of training by health workers, report on accuracy of data management and generate evidence for supporting adjustments to severe malaria case management strategies.

The Democratic Republic of the Congo adopted the strategy of using, at the community level, a dose of rectal artesunate as a pre-referral treatment for severe malaria amongst children under 5 years who could not quickly reach a health care facility and take oral medication. However, the adherence to referral advice after the integration of this strategy and the acceptability of the strategy were unknown. Results here.
