- 5) Closer collaboration of working groups


AMP 2012 – Mentoring programme

- Formalize what AMP has supported since the first countrywide campaign in Togo 2004. To date capacity building has been uneven and where it exists it is often committed to a programme.
- Build on existing capacity to develop a pool of skilled, African based TA providers.
- Countries will be responsible to define where they want to build capacity in anticipation of upcoming LLIN scale up activities
- Focus will be building NMCP capacity in-country and at a regional level by shadowing an AMP TA provider in county and establishing a mentoring relationship at a distance.
- Expand country to country exchanges

AMP 2012 - Dissemination of toolkit 2.0

10 chapters including:

- Coordination
- Planning
- Procurement
- Logistics
- Communication
- Implementation
- Monitoring and evaluation
- Campaign reporting
- Sustaining gains: moving beyond scale up



AMP 2012 – Trainings

- Two workshops planned third quarter of 2012.
- Scale Up and Sustaining Gains and Logistics with a joint session on procurement.
- Objective will be to ensure extensive country exchanges

Criteria for participation:

- Have unimplemented Global Fund or partner funding for mass LLIN distribution;
- Have not yet achieved universal coverage with LLINs;
- Are applying for Transitional Funding Mechanism grants and an LLIN campaign component is included;
- Are applying for Transitional Funding Mechanism grants and working to develop or strengthen continuous distribution systems; and
- Have recently (in 2010 / 2011) undertaken LLIN scale up campaigns and are working to develop or strengthen continuous distribution systems.
- French 13 countries and English 15 countries
 Expanding the ownership and use of mosquito nets

AMP 2012 – Deployment of technical assistance

- 2012 planning for 31 TA missions including missions outside Africa
- 50% implementation (including continuous distribution) / 35% logistics, 10 % communications, 5% M&E
- Increasing number of requests for technical support in developing a single strategy that aligns mass scale up and continuous distribution as well as more requests for M&E support
- 360° technical assistance

AMP 2012 – Opportunities for expanded collaboration of working groups

Cross-cutting:

- Supporting programmes outside Africa. AMP can learn from VCWG on this issue.
- Joint fundraising and advocacy. Where priorities align develop a joint fundraising or advocacy position.
- AMP remains open to expanded collaboration and to hearing from the VCWG on priorities / proposed areas of collaboration.

AMP 2012 – Opportunities for expanded collaboration of working groups

BCC working group – Hannah Konker (JHU / Networks):

Extending the life span of LLINs.

Emerging issues – Megan Fotheringham (USAID / PMI):

- Net durability and waste management. Countries are requesting clear and consistent guidelines that are context appropriate.
- ITN and IRS overlap. Guidance to countries on whether they distribute LLINs in areas that have already been sprayed.
- Data management

AMP 2012 – Opportunities for expanded collaboration of working groups

Sustaining gains – Elena Olivi (PSI) & Stefan Hoyer (WHO-GMP):

- How do we sustain the gains we have achieved with less resources.
- Strengthen linkages between AMP sustaining gains working group and VCWG continuous distribution
- How campaigns and routine align? How do we sustain coverage in settings where we don't have continuous distribution established?

AMP 2012 – Opportunities for expanded collaboration of working groups

Operations research – George Greer (USAID / PMI) & :

VCWG input into develop a new set of OR priorities this week.

Technical assistance – Marcy Erskine (IFRC):

- Continuous distribution: how can we support in implementing guidance?
- Where there are existing LLINs what do we do? If there are guidelines how do we disseminate them more quickly.
- If the guidelines are there we are not aware and cannot answer these questions.
