### **MSP Focus (Goal & Objectives)**

Goal: To achieve zero local malaria transmission in Botswana by 2020

Botswana's NMP 2018-2023 Strategic Objectives

- To achieve universal coverage of appropriate preventive interventions for all population at risk of malaria in all transmission foci
- To strengthen social behaviour communication and community engagement to achieve at least 85% utilization of malaria interventions
- Establish a fully functional Malaria Elimination surveillance,
  Monitoring and Evaluation system to enable effective detection and response to 100% of Malaria infections
- To strengthen capacity of the National Malaria Program for effective leadership and coordination of Malaria elimination
- To identify and provide treatment to all persons with Malaria infections according to national guidelines




#### Malaria Cases and Deaths, 2009 -2023 Malaria season



Stagnation of cases in Botswana with the highest peak of cases (953) and deaths (11) reported in 2020


#### Malaria Incidence per 1000 population, 2006-2022

- □Appointment of Malaria focal person at National Health Lab-enhanced capacity for diagnosis

# Key Bottlenecks/Challenges encountered and how they were addressed

(a) Withdrawal of GF funding

Inadequate funding through GF sub recipients such as E8

(b)Intervention fatigue (IRS)

-Progress towards elimination is stagnant



❖ Reorient the programme into elimination mode

(c)The entomology laboratory is functioning sub optimally
