

# Malaria commodities: ensuring continued availability and affordability of life-saving tools during the COVID-19 pandemic

COVID-19 has affected the demand for and availability of life-saving malaria commodities. Lockdowns around the world have resulted in disruptions to global health product supply chains and distribution across the full product lifecycle. Meanwhile, demand for tests and potential therapies for COVID-19 has created potential shortages and price hikes for malaria Rapid Diagnostic Tests (RDTs) and Active Pharmaceutical Ingredients (API) used in malaria medicines. African countries, which account for over 90% of the global malaria burden, are particularly dependent on imported products and vulnerable to disruptions to product supply chains and national distribution systems triggered by COVID-19.



## The role of governments and the private sector

Governments, private sector organisations and other partners involved in the supply-chain of malaria commodities must be held accountable to:

- Maintain and step-up commitments to produce malaria commodities and their starting materials
- Minimise production and delivery delays and bottlenecks within countries producing and receiving commodities
- Improve co-ordination between global manufacturing, procurement and delivery partners
- Increase R&D to develop new, transformative technologies for the fight against malaria





## Availability of malaria commodities in Africa (as of June 2020)

- There is an urgent need for additional **105 million malaria RDTs in 2020 alone**, the annual RDT Suppliers Forum revealed on 16 June
- Of the 65 countries being monitored worldwide, **14 countries** have low stocks of RDTs and **12 countries** have low stock of ACTs
- Insecticide-treated net (ITN) distribution campaigns have been delayed in **Angola** and **Zambia** due to net shipment delays
- Delays to SMC deliveries in **Mali, Togo and Chad** could affect availability of these medications and delay campaigns

### State of malaria snapshot

- On 26 June, UNICEF's Supply Division reported its 2019 achievements including: procuring **34.98 million** artemisinin-based combination therapy malaria treatments; **2.6 million** treatments for seasonal malaria chemoprevention; and delivering **4.2 million** malaria rapid diagnostic tests to **19 countries**
- On 24 June, the Global Fund to Fight AIDS, Tuberculosis and Malaria estimated that in response to COVID-19, **US\$28.5 billion** is needed to protect the past two decades of progress in countries affected by these three diseases. In a survey, 73% of malaria programs in 106 countries reported disruption to service delivery (with 19% reporting high or very high disruptions).
- On 17 June, the **World Health Organization (WHO)** stopped trialing hydroxychloroquine as a treatment for COVID-19
- According to the World Health Organization's latest **World Malaria Report**, there were **386,000** malaria deaths in Sub-Saharan Africa in 2018
- Data from the World Health Organization shows that COVID-19 is threatening to double deaths against malaria in Sub-Saharan Africa, reaching up to **769,000** deaths in 2020.
