

should go where

Monitor

- What interventions have gone where?
- What is coverage?
- How do we determine population covered/protected?
- How do we optimize implementation?
- What are the particular challenges around mobile populations/emergencies/PANDEMICS
- What are the barriers, limitations, best practices and possibilities in detailed information on implementation?

Evaluation

- What kind of evaluation exist?
 - Operations research (ties with monitor)
 - Broad impact evaluations
 - Sub-national evaluations of tailoring strategies
 - Specific intervention or intervention mix evaluations
- What are the best kinds of methodologies?
 - In different burdens
 - In different mixes
 - With different methodologies (survey, routine data, entomological....)
- What are the potential uses/challenges/best practices?
