# Monitoring and Evaluation Reference Group Purpose

The purpose of the RBM Partnership to End Malaria's Monitoring and Evaluation Reference Group (RBM MERG) is to facilitate alignment of partners on strategies and "best practices" in surveillance, monitoring, and evaluation (SME) of malaria control and elimination programs. It also identifies emerging questions and needs related to the implementation of SME initiatives, communicates these to appropriate partners, and brainstorms solutions.

# Monitoring and Evaluation Reference Group Meeting Overall Objectives

- 1. **Harmonize SME activities** to leverage partner resources and avoid duplicating efforts
- 2. **Identify and prioritize** actions for county, regional, and global SME work
- 3. **Identify critical SME bottlenecks** and organizing specific task forces to address the challenges and provide recommendations
  - 4. **Promote operational research** to support evidence-based, efficient program implementation and use of the SME tools
    - 5. Identify and recommend strategies for capacity building in SME
- 6. **Develop and maintain consensus** around SME strategies across partners and institutions
  - 7. **Monitor changing needs for SME** as country programs, and the RBM partnership itself evolve
